Position: BILLING ASSISTANT II

Closes: Open Until Filled

High School Diploma or GED. Three years recent experience (within last 4 years), in a medical billing department.

COMMUNITY HEALTH

Position: TOBACCO CESSATION SPECIALIST

Closes: August 3, 2010

Prior tobacco cessation, patient health education and direct patient care experience required. Must have certification in Tobacco Cessation or have ability to obtain certification within one (1) year of hire. Must be tobacco free for at least nine (9) months and must remain tobacco free for duration of employment. Current CPR/BLS required. Must also meet one of the following education/experience requirements:

- 1) Current WA State Registered Nurse (RN) license with five years experience; or
- 2) Current WA State Licensed Practical Nurse (LPN) license with seven years experience.

Current CPR/BLS certification required and must obtain Health Care Assistant (HCA) license upon hire. *Note:* completion of phlebotomy course does not qualify for meeting minimum requirements.
