**WHEREAS**, the Northwest Portland Area Indian Health Board (NPAIHB), a tribal organization under P.L. 93-638 that represents forty-three Federally-recognized Indian tribes in Oregon, Washington and Idaho, and

**WHEREAS**, the Northwest Portland Area Indian Health Board is dedicated to assisting and promoting the health needs and concerns of Indian people; and

**WHEREAS**, the primary goal of the NPAIHB is to improve the health and quality of life of its member tribes; and

**WHEREAS**, the Northwest Portland Area Indian Health Board has proposed a legislative plan which identifies key health care issues facing American Indian and Alaska Native health programs in 2004; and

**WHEREAS**, the second session of the 108th Congress will take up consideration of the issues identified in the legislative plan.

**NOW THEREFORE BE IT RESOLVED** that the NPAIHB adopts its FY 2004 Legislative Plan and directs staff to assist tribal leaders and delegates in their lobbying efforts to implement the plan.
