RESOLUTION #04-03-06
**Support for HIV Prevention Services into
Reproductive Health and Community Settings**

WHEREAS, the Northwest Portland Area Indian Health Board (NPAIHB), a tribal organization under P.L. 93-638 that represents forty-three Federally-recognized Indian tribes in Oregon, Washington and Idaho on health related issues, and

WHEREAS, the Northwest Portland Area Indian Health Board is dedicated to assisting and promoting the health needs and concerns of Indian people, and

WHEREAS, the primary goal of the Northwest Portland Area Indian Health Board is to improve the health and quality of life of its member tribes, and

WHEREAS, the Center for Disease Control and Prevention is currently soliciting proposals to support HIV and other prevention services in reproductive health and community settings in order to prevent STD and HIV transmission, and unintended teen pregnancies, and

WHEREAS, HIV, the virus that causes AIDS, poses a potentially devastating threat to the health and well-being of Indian people, and

WHEREAS, over 2,527 American Indians/Alaska Natives are currently living with HIV-AIDS as reported by CDC and impacts many Indian families, and

WHEREAS, Project Red Talon is a project of the Board that is experienced to provide HIV education, prevention, and integration services in tribal communities and the objectives of the grant program are consistent with the goals of the project.

NOW THEREFORE BE IT RESOLVED that the Northwest Portland Area Indian Health Board supports the submission of a grant to the CDC for HIV prevention and integration funds.
