PURPOSE:

On Wednesday and Thursday, June 10-11, 2009, the Indian Health Service (IHS)/Tribal Contract Support Cost (CSC) Workgroup will convene in Phoenix, Arizona. The Workgroup meeting will focus on IHS CSC policy and resource allocation issues. At a minimum, the following issues will be discussed:

- IHS CSC Policy Allocation methodologies associated with new or expanded awards.
- Allocation of FY 2009 and 2010 CSC appropriation.
- Impact of National Business Center Indirect Cost Rate negotiation changes.
- CSC need associated with American Recovery & Reinvestment Act (ARRA) funds.
- Development of a report on CSC over the past 10 years.
- Other issues associated with IHS CSC policy or issues raised by Tribal participants.

ANTICIPATED OUTCOMES:

- In-depth discussion and review of comments and development of recommendations on anticipated policy changes for recommendation to the IHS Director.
- Tribal representatives may also develop Tribal-specific recommendations or guidance for the Director.
- This is also an opportunity for Tribal participants to learn about IHS CSC Policy and current hot issues facing Tribes and the IHS on a local and national level.

As always, all CSC allocation methodologies of the IHS are open to discussion. We will not, however, discuss ongoing litigation nor debate the merit of any Tribal CDA claims pending against the Agency. A complete agenda will be provided at the meeting.
