This year we have added finance related sessions due to conversion to a new accounting system, UFMS. Over 100 offered sessions target knowledge, skills and capabilities of revenue generating staff that work in our hospital and clinics. For every session, by the time it is finished, the users/attendees should have acquired new information, skill(s) or capabilities that they can use to improve their jobs in the Service Unit.
