Meaningful Use: The American Recovery and Reinvestment Act of 2009 authorized the Centers for Medicare & Medicaid Services (CMS) to provide a reimbursement incentive for eligible professionals and hospitals who are successful in adopting and meaningfully using an Electronic Health Record (EHR) that is certified under the new Office of the National Coordinator (ONC) certification criteria. These incentive payments for Medicare begin in 2011 and continue through 2016. For Medicaid, States will determine when they launch their EHR Incentive Programs. CMS expects that most States will launch their programs in 2011. Medicaid EHR incentive payments continue through 2021. For Medicare, starting in 2015, eligible providers who cannot demonstrate meaningful use of certified EHR technology will be subject to financial penalties.

Accessing Federal Supply Sources: Tribes and Tribal organizations contracted under the Indian Self-Determination and Education Assistance Act (ISDEAA) access Federal Supply Sources under the authority of Sections 105(k) and 508(e) of the ISDEAA, 25 U.S.C. §§ 450j(k) and 458aaa-7(e). In the event that an Indian Tribe elects to carry out an ISDEAA contract or compact with the use of Federal personnel, supplies, supply sources, or other resources (including resources available under any procurement contracts in which the Department is eligible to participate), the ISDEAA requires that the IHS acquire and transfer such personnel, supplies, or resources to the Tribe. Tribes may access such sources of supply under the same terms and conditions as an executive agency. This session will explore the benefits of Tribal access to Federal Supply Sources, as well as, create a forum for Tribes to share recommendations or identify challenges they are currently facing in accessing Federal Supply Sources.
