HHS strives to continuously improve the consultation process and in order to facilitate better communication and consultation with Tribes we will develop an improved agenda format for the 2012 ATBC based on feedback from Tribal and Federal participants. The Department understands the importance of hearing from Tribes on national crosscutting issues, regional perspectives, as well as Tribal-specific concerns and has developed a format that will allow for all.

As in previous years, the respective Regional Tribal Consultations that take place in the field will be coordinated by the respective Regional Offices and with the Tribes in their regions. Dear Tribal Leader:

I write to invite you to the 14th Annual U.S. Department of Health and Human Services (HHS) Tribal Budget Consultation (ATBC), which will take place from March 7-9, 2012, in the Great Hall of the Hubert H. Humphrey Building at 200 Independence Avenue, SW, Washington, DC, as well as to our 2012 Annual Regional Tribal Consultations hosted across the country. Please see the first attachment for the list of dates of the regional consultations.

HHS strives to continuously improve the consultation process and, in order to facilitate better communication and consultation with Tribes, we developed an improved agenda for the 2012 ATBC based on feedback we received from Tribal and federal participants. The Department understands the importance of hearing from Tribes on national crosscutting issues, regional perspectives, and Tribal-specific concerns, and the new format allows for a comprehensive session.

This letter provides you with a brief description of our consultations, information for participation in the regional sessions, and information for the planning of the ATBC. As in previous years, the Regional Tribal Consultations that take place in the field will be coordinated by the respective Regional Offices and with the Tribes in their regions. They will include one-on-one time with the Regional Director and regional leaders of other HHS agencies.

As for the ATBC session, we will once again host a Tribal Resource Day, on Wednesday, March 7, 2012, at HHS in Washington, DC. The Tribal Resource Session will give an overview of the programs, grants, and services that the Department provides to Tribes. This session is particularly helpful for newly-elected Tribal leaders or others who want a comprehensive introduction to the Department.

On Thursday, March 8, 2012, from 8:30 a.m. to 12:00 p.m., we will provide individual Tribes time for one-on-one meetings with HHS officials on health and human service issues that are specific to their individual Tribe. Officials from various HHS agencies will be available to add to the conversation. For this specific portion of the consultation we ask that you pre-register so that the meetings run smoothly and all Tribes have an opportunity to meet with HHS representatives. Please note that the amount of time that you are allotted to meet with individual HHS officials will be determined by the volume of requests. To pre-register for one-on-one meeting time, please email your request, and include the agency/agencies you would like to meet, to consultation@hhs.gov.

At 1:30 p.m. on Thursday, March 8, 2012, we will begin the consultation session. HHS will have a few issues on which we would like to consult with Tribes, and our intention is to have these topics identified and sent to you in the next few weeks so that you can prepare your thoughts, ideas, and recommendations.

The consultation will also provide a forum for Tribes to collectively share their views and priorities on national health and human services funding and recommendations for the Department's Fiscal Year 2014 budget request with me, my Budget Advisory Council, and other HHS officials. We hope the consultation will provide a venue for a two-way conversation between Tribal leaders and HHS officials on program issues and concerns that will lead to recommended actions and/or solutions.

In order to ensure Tribal input in the development of the ATBC, HHS will begin hosting planning calls, with the first one scheduled for Thursday, January 19, 2012, at 3:00 p.m. EST. The second attachment to this letter provides a recap of last year's ATBC and provides details for this year's planning.

Summary of 13th Annual National HHS Tribal Budget Formulation and Consultation Session

At the 2011 Consultation Session, Tribal representatives provided testimony, received responses from HHS leadership regarding the budgets and policies of nine HHS agencies, and participated in a department-wide discussion on crosscutting issues.

The following crosscutting issues were identified at the 2011 session:

1. Affordable Care Act Overview.
2. State Budget Reductions Impacting Medicaid

Tribal Recommendations:

1. Behavioral Health – Tribes requested additional financial resources, service integration, and coordination across HHS.
2. Diabetes – Combating diabetes and its resultant complications remains a top health priority in Indian country.
3. Cancer – Tribes noted that limited access to cancer screenings and lack of specialized care contributes to the increasing cancer mortality rate among AIAN, at a time when cancer deaths have been declining overall across the United States.

The President's FY 2012 Budget proposes an increase in HHS funding targeted specifically toward serving the needs of American Indians and Alaskan Natives, including an increase of \$571 million, or 14 percent more than FY 2011, for the Indian Health Service. The budget also includes an increase of \$50 million at SAMHSA for a new Tribal Block Grant Program focused on behavioral health and prevention as well as increases for AI/AN programs at ACF and AoA.
