I write on behalf of the National Tribal Contract Support Cost Coalition (NTCSCC), a Coalition of 20 tribal organizations and Tribes situated in 11 States across the Nation, and representing 290 Tribes.

In response to your March 2, 2012 letter soliciting comments regarding the above-referenced issue, I write to advise you that none of the Tribes or tribal organizations comprising the NTCSCC have expressed any concerns regarding the sharing of their individual tribal data with other Tribes, tribal employees and technical staff. This has been the case since 1988—nearly 25 years—and we the NTCSCC Tribes and tribal organizations have no objection to this continuing in the years to come.
