Dear Tribal Leader,

The Department of Health and Human Services (HHS) is pleased to announce a workshop on tribal grants access at the Hubert Humphrey Building in Washington, DC, on October 8 - 9, 2013. Tribes have consistently told HHS leadership about their difficulties in successfully obtaining HHS grant funding; as a result, the Department, with recommendations from the Secretary's Tribal Advisory Committee, has made improving tribal access to HHS grants a priority.

In December 2011 over 200 HHS staff participated in a "Supporting Tribal Access to Grants" training and workshop designed to increase their knowledge of tribal communities. On April 17, 2012, HHS hosted a webinar for tribal communities titled, "Finding HHS Grant Opportunities for Tribes." Both the workshop and webinar received positive feedback but also indicated that more work is needed. In response, the Department has worked hard to develop a workshop that both tribes and HHS staff can participate in together to improve tribal access to grants.

The workshop is designed to be informative and interactive and will include presentations, panel discussions, and technical assistance. In addition, the Department will unveil and provide technical assistance for the newly developed Grants Eligibility Tool that was designed to compliment other grant tools that tribes currently use to track grant-funding opportunities.

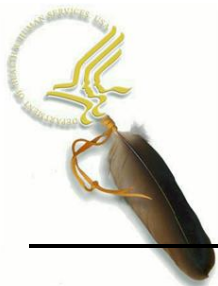

Objectives:

- To inform tribal communities about current HHS tools for accessing grant opportunities and the grants process at HHS
- To receive feedback from tribal communities on how HHS can improve accessibility

It will include discussion on each of the tools used to identify current funding opportunity announcements for which Tribes are eligible.
10:00-12:00 P.M.	Overview of Grant Review PURPOSE: This session will provide a brief review of the different ways HHS does grant review followed by a discussion on best practices as seen by the Tribes. HHS staff will also promote becoming grant reviewers to the tribal participants.

1:00-2:00 P.M.	Grants Reporting PURPOSE: This session will include a discussion on grant reporting requirements across HHS. Tribes will have the opportunity to discuss the challenges with these reporting requirements.
2:00-3:00 P.M.	Evaluation and Auditing PURPOSE: This session will include a discussion on the different evaluation and auditing processes across HHS. Tribes will have the opportunity to discuss how Tribes perceive evaluations and auditing and how this process could be improved to meet tribal needs.
3:00-4:30 P.M.	Access Challenges PURPOSE: This session will include a discussion on the 2009 Barriers report, the work that has been done to address the issues identified in the report and further work that Tribes identify as needed.
