The [Robert Wood Johnson Foundation](#) is accepting proposals that apply the principles and frameworks of behavioral economics to persistent and perplexing health and healthcare problems. Proposals are encouraged from a range of disciplines, including but not limited to behavioral economics, decision theory, economics, public health, sociology, psychology, marketing, nursing, and medicine.

Through its Pioneer Portfolio program, RWJF expects to make approximately five awards of up to \$200,000 each for two-year projects that test innovative solutions to the challenge of reducing the use of low-value services in health care — those that provide more harm than benefit or which provide only marginal health benefits. Projects that could fall under this category include experiments that vary the frame or structure of information or messaging to patients or providers in a way that might reduce the use of clinical services of low or questionable value; experiments that reflect or modify social connections or norms that might reduce the use of these services; or experiments that use choice architecture or financial incentives informed by techniques of behavioral economics to reduce the use of these services.

The program is particularly interested in funding proposals in which academic teams collaborate with an outside organization, corporation, or partner whose constituents and/or infrastructure are suitable for the testing of promising behavioral economic approaches.

Projects funded under this initiative should complement the work of the RWJF-supported [Choosing Wisely initiative](#). Choosing Wisely, which is run in partnership with *Consumer Reports*, is designed to help physicians and patients engage in conversations about the overuse of tests and procedures; it also supports physician efforts to help patients make smart and effective care choices.

Priority will be given to applicants who are considered tax-exempt under Section 501(c)(3) of the Internal Revenue Code and are not private foundations as defined under Section 509(a).

There are two stages in the competitive proposal process. Applicants must submit a 1,500-character proposal brief that describes the project by April 17, 2013; and, if invited, submit a full proposal and line-item budget for future consideration. Applicants selected to submit a full proposal will be notified on May 29, 2013. Full proposals must be submitted no later than July 17, 2013.

- **HUD: Department of Housing and Urban Development Transformation Initiative: Sustainable Construction in Indian Country Small Grant Program Grant**

**Deadline:** March 25, 2013

**Amount:** HUD anticipates that approximately 4 to 8 awards will be made ranging from \$50,000 to a maximum of \$100,000 per award. The maximum grant performance period for an award under this program is 24 months.

**Description:** HUD invites applicants to submit proposals for funding that encourages the use of sustainable construction practices in Native American housing. Proposals should take into account the multiple geographic, economic and cultural aspects of Native American residential design and construction. HUD seeks applications in four broad areas: demonstration, technical assistance, curriculum development/training, and information dissemination related to sustainable construction in the Native Community. Activities performed under the Sustainable Construction in Indian Country Small Grant Program should document the impact of one or more innovative approaches to sustainable construction in Indian Country, identify a set of lessons learned, and then develop, deploy or distribute a tool highlighting those lessons. This tool should support learning without the need for instructors, facilitators or other external assistance. The training media may include, but are not limited to, a blog, DVD, publication, and video. Media of this type is expected to be maintained by the grantee until the end of the agreement.

**Description:** Sexual assault, domestic violence, dating violence, and stalking are crimes that require the criminal justice system to hold offenders accountable for their actions through investigation, arrest, and prosecution of violent offenders, and through close judicial scrutiny and management of offender behavior.

The discretionary Grants to Encourage Arrest Policies and Enforcement of Protection Orders Program (Arrest Program) is designed to encourage State, local, and Tribal governments and State, local, and Tribal courts to treat sexual assault, domestic violence, dating violence, and stalking as serious violations of criminal law requiring the coordinated involvement of the entire criminal justice system. The Arrest Program challenges the community to listen, communicate, identify problems, and share ideas that will result in new responses to ensure victim safety and offender accountability. ➤ **Evaluating the Effectiveness of State, Local and Tribal Responses to Violence Committed Against Indian Women Living in Tribal Communities**

**Deadline:** April 22, 2013 (Applicants must register with Grants.gov prior to submitting an application. OJP urges applicants to **register 72 hours prior to** the application submission deadline. The deadline to apply for funding under this announcement is **11:59 p.m. eastern time** on **April 22, 2013.**)

**Amount:** NIJ anticipates that up to a total of \$500,000 may become available for one or two awards made through this solicitation. **All awards are subject to the availability of appropriated funds and to any modifications or additional requirements that may be imposed by law.** NIJ funding for an individual research project rarely exceeds \$500,000, though total funding for projects requiring multiple years to complete has exceeded \$1 million in some cases.

Applicants should be aware that the total period for an award ordinarily will not exceed 3 years.

**Description:** Title IX, Section 904(a) of the Violence Against Women and Department of Justice Reauthorization Act of 2005 (VAWA 2005), Public Law Number 109-162 (codified at 42 U.S.C. § 3796gg-10 note), calls for the National Institute of Justice (NIJ) to conduct analyses and research on violence against Indian women living in Indian Country. In conducting its analyses and research, this section asks NIJ to, in consultation with the Office on Violence Against Women (OVW), conduct a “national baseline study” focusing on domestic violence, dating

violence, sexual assault, stalking, and murder, and evaluating the effectiveness of responses to those violations. To date, NIJ has made significant progress in evaluating the effectiveness of federal responses to crimes committed against American Indian and Alaska Native women living in tribal communities. However, State, local, and tribal responses have not been evaluated. This solicitation seeks proposals to conduct evaluations of promising programs that effectively respond to violence against Indian women living in tribal communities managed by State, local, or tribal governments.

Advocates report that survivors are more inclined to seek services from organizations that are familiar with their culture, language and background and that there is no “one size fits all” approach to adequately address these critical needs. Culturally specific community-based organizations are more likely to understand the complex multi-layered challenges and obstacles that victims from their communities face when attempting to access services. community-based organizations are also better equipped to form essential relationships and engage their communities in the creation and implementation of services relevant to the diverse and unique needs of the victims.

This discretionary grant program is designed to fund new and existing programs that provide culturally specific services to sexual assault, domestic violence, dating violence, and stalking victims. ### ➤ **Healthy Eating Research 2013 Call for Proposals**

The 2013 Call for Proposals (CFP) is for two types of awards aimed at providing advocates, decision-makers, and policy-makers with evidence to reverse the childhood obesity epidemic. The award types are:

- **Round 8** grants, representing the majority of RWJF's investment in research through this program. Approximately \$1.4 million will be awarded through Round 8. Each grant will award up to \$170,000 for a maximum funding period of 18 months. There are **three deadlines** for receipt of **concept papers** (all by **3pm ET**): **February 13, April 24, and July 10.**

The Office of Juvenile Justice and Delinquency Prevention (OJJDP) has announced the following fiscal year 2013 funding opportunities:
