Secretary Kathleen Sebelius announced that more than half of all doctors and other eligible providers have received Medicare or Medicaid incentive payments for adopting or meaningfully using electronic health records (EHRs). HHS has met and exceeded its goal for 50 percent of doctor offices and 80 percent of eligible hospitals to have EHRs by the end of 2013. View the full release here.

Affordable Care Act News

May 17, 2013

The Centers for Medicare & Medicaid Services (CMS) issued the Pre-Existing Condition Insurance Plan (PCIP) Program Provider Payment rule. Under the Affordable Care Act, this interim final rule adjusts pre-existing condition insurance plan provider rates to reduce the rate of program expenditures. May 17, 2013

The Centers for Medicare & Medicaid Services (CMS) issued a final rule implementing the Affordable Care Act Medical Loss Ratio (MLR) requirements for Medicare Advantage (MA) and Part D prescription drug plans. The final rule limits how much plans can spend on marketing, overhead, and profit. The minimum MLR requirements will promote greater value for Medicare beneficiaries enrolled in MA and Part D plans as well as promote greater accountability and transparency. Similar MLR requirements are already benefiting consumers in the private health insurance market. View the full here and blog posting here.
