The Consumer Protection Division of the Washington State Attorney General's Office (AGO) enforces the state Consumer Protection Act in order to provide a marketplace free from unfair and deceptive practices. Our work is accomplished by educating our constituency, providing informal complaint resolution between businesses and consumers, working for changes through the legislative process, and taking legal action against those that violate the Consumer Protection Act.

The resolution of lawsuits brought by the AGO often will result restitution payments to

compensate injured consumers. Although we first try to get the money back to consumers directly, at times it is impossible or impractical to do so. In those instances, the court may allow us to indirectly compensate injured consumers by proposing a "next best use" for the settlement funds. These funds, called "cy pres" funds, may be used for programs that benefit the class of individual or business consumers who were harmed by the unlawful acts. For example, recoveries from a settlement with a defendant that preyed on senior citizens may be used to benefit the affected class of consumers by supporting a consumer education program specifically targeted to helping senior citizens who live in the geographic area where the unlawful conduct occurred avoid becoming victims of similar scams. A court might also permit a broader use of the funds, such as helping senior citizens generally. The AGO and any beneficiaries of cy pres funds must comply with any restrictions placed on the funds by the court.

Projects must use the CPS Model, comprised of seven elements of a successful collaborative partnership, to address local environmental and/or public health issues. Because EPA requires substantial involvement and interaction between the applicant, EPA regions and OEJ, these awards will be made in the form of cooperative agreements.

A cooperative agreement is an assistance agreement that is used when there is substantial federal involvement with the recipient during the performance of an activity or project. EPA awards cooperative agreements for those projects in which it expects to have substantial interaction with the recipient throughout the performance of the project.

Eligibility

SAMHSA is limiting eligibility for this program to mental health consumer-controlled organizations only that are domestic public and private nonprofit entities, tribal and urban indian organizations, and/or community- and faith-based organizations. A primary goal of the program is to strengthen the capacity of consumers to act as agents of transformation in influencing the type and amount of services, so they must be an integral part of an organization that supports individuals with a serious mental illness or who have received public mental health services, and ensures that their mental health care is consumer driven with access to recovery support services. Therefore, only organizations controlled and managed by mental health consumers are eligible to apply

Consumer-controlled organizations must meet the following requirements:

An applicant organization must complete the Certificate of Eligibility (see Appendix K of this RFA) indicating that the applicant meets all eligibility requirements.

In order to strengthen and expand the impact of this program across the nation and ensure broad geographic distribution, SAMHSA will make only one award per state, territory, or tribe and is limiting eligibility to applicants in states, territories, and tribes that do not have a currently funded Statewide Consumer Network grant.

Awards will be focused on renovation. • The Bureau of Justice Assistance (BJA) will not award any planning grants under Purpose Area #4. 2013 NACA Program Awardees Will Stimulate Economic Development in Low-Income Areas

Washington, DC – Native American, Alaska Native, and Native Hawaiian communities (Native Communities) throughout the United States will receive much-needed economic and community development assistance as a result of the \$12.4 million in Native American CDFI Assistance Program (NACA Program) awards announced today.

Thirty-five organizations serving Native Communities received awards from the U.S. Department of the Treasury's Community Development Financial Institutions Fund (CDFI Fund) under the fiscal year (FY) 2013 round of the NACA Program. The awardees all aim to increase lending and financial services in Native Communities, stimulating economic development in some of the most distressed and low-income parts of the country.

"The Native American CDFI Assistance Program is providing critically needed funds for distressed Native and tribal areas, many of which lack traditional banking services," said Don Graves, Treasury Deputy Assistant Secretary for Small Business, Community Development and Housing Policy. "This latest round of awards will expand the capacity of native financial institutions to develop innovative economic development solutions for the businesses and individuals in their communities."

The awardees, all certified Native Community Development Financial Institutions (Native CDFIs) or organizations looking to become or create Native CDFIs, will receive a collective total of \$12,451,015 in Financial Assistance and Technical Assistance awards. Eighteen Native CDFIs will receive Financial Assistance awards, which are primarily used for financing capital. Seventeen organizations will receive Technical Assistance grants, which are usually used to acquire products or services, staff training, professional services, or other support.

"The FY 2013 NACA Program awards will lead to increased loans for small businesses, affordable housing, and community facilities in Native Communities, in addition to basic financial services that are essential to building household wealth and stability," said CDFI Fund Director Donna J. Gambrell. "As the award-making arm of the CDFI Fund's Native Initiatives, the NACA Program has consistently supported the unique organizations that are doing such vital work in these communities."

The majority of the target markets served by the awardees are rural, although seven organizations primarily serve minor urban areas. The organizations are headquartered in fifteen different states across the country.
