# C-19 Emergency Response - NPAIHB Situation Report: 12/15/20

#### Keys to Victory

- Vaccinations: Pfizer vaccine approved, distributed to states and IHS
  - ► Moderna vaccine FDA EUA approval expected, distribution next week
    - ▶ Discussion on Wednesday COVID-19 ECHO
- Community Engagement: community rates, risks and the preventive measures
- Policy, education, and enforcement: Mandatory masks and limitations on gatherings/number of people per setting
- ► Testing and Tracing: consider screening testing for essential workers, group settings
  - ► Keep up the investigations and tracing move to surge practices if needed



- 2. Inform health professional education programs and schools across the region
- 3. Illuminate the economic impact of Tribal health workforce

## Legislative and Policy Update

#### Legislative and Policy Update (as of 12/15 at 9:00am)

- Continuing Resolution in place until 12/18/2020 (includes SDPI and Tribal TANF)
- Veterans Health Care and Benefits Improvement Act of 2020 passed the Senate on 12/9
  - Amends statutes to prohibit co-pays at VA clinics for AI/AN veterans
  - Forms Tribal Advisory Committee to the Secretary of Veterans Affairs
  - Allows MOUs between IHS and VA so case managers can provide housing case mgmt

#### COVID-19 Relief Package - split into two bill bills

- Bi-Partisan State and Local Support and Small Business Protection Act of 2020
  - Extension for spending CARES Act funds to 12/31/2020
  - \$152b to state and local governments
  - \$8b for Tribes (allocated 60% population, 40% # of employees of each Tribal entity)

#### Legislative and Policy Update (as of 12/15 at 9:00am)

- Emergency Coronavirus Relief Act of 2020
  - \$1b in Provider Relief Funds for I/T/U system
  - \$129m from the CDC for vaccinations/infrastructure for I/T/U (can be transferred to IHS)
  - \$350m in grants to I/T/U for COVID-19 testing/tracing
  - \$185m I/T/U set-aside under SAMHSA, with language that allows a transfer to IHS
  - \$50m Tribal set-aside for Tribal Opioid Response grants
  - \$50m for the Food Distribution Program on Indian Reservations
  - Telehealth waiver extensions to 12/31/2021
  - Extension of unemployment assistance (additional \$300/week for 16 weeks)

#### Legislative and Policy Update (as of 12/15 at 9:00am)

- New bi-partisan, bi-cameral legislation introduced re Surprise Medical Billing
  - Holds patients harmless in emergency situations; not able to choose in-network providers
  - Prohibits some balance billing by out-of-network providers
  - Creates an independent dispute resolution process
  - Includes additional consumer protections
- FY 2021 Omnibus Appropriations legislation (\$1.4 trillion, text due today)
  - Compromises reached on border wall, ICE detention capacity, and veteran's healthcare funding
  - If it moves forward, will most likely include COVID package(s) and Surprise Medical Billing leg
- Multiple Final Rules and Rulemaking changes published in the Federal Register
  - HIPAA proposed changes (improves patient rights, improves E-PHI sharing, changes some admin processes)
  - Final rule re. 340b Drug Pricing Program (established an Alternative Dispute Resolution process)
  - CMS proposed changes to Medicaid/CHIP re prior authorizations and HIE
  - CMS extended blanket waivers through the end of the public health emergency

#### NPAIHB Medicare/Medicaid Policy Support

- Background: Tribal Technical Advisory Group to the Center for Medicare and Medicaid Services has a subcommittee focusing on Medicare/Medicaid policy issues
- There are some common themes throughout Indian Country
  - Medicaid Managed Care Organizations (MCO): Limited understanding re. Indian Health Care system
  - Same billing denials for services happening in different Areas (i.e. non-contracted provider denials)
  - Pharmacy Benefits Management (PBM) companies not paying, paying incorrectly, takebacks
  - Need to develop best practices what works and why
- NPAIHB would like to know if you or your business office staff need support in this area, if
  you have specific challenges with MCO's or PBM's, and if you have successes you would like
  to share as a best practice
