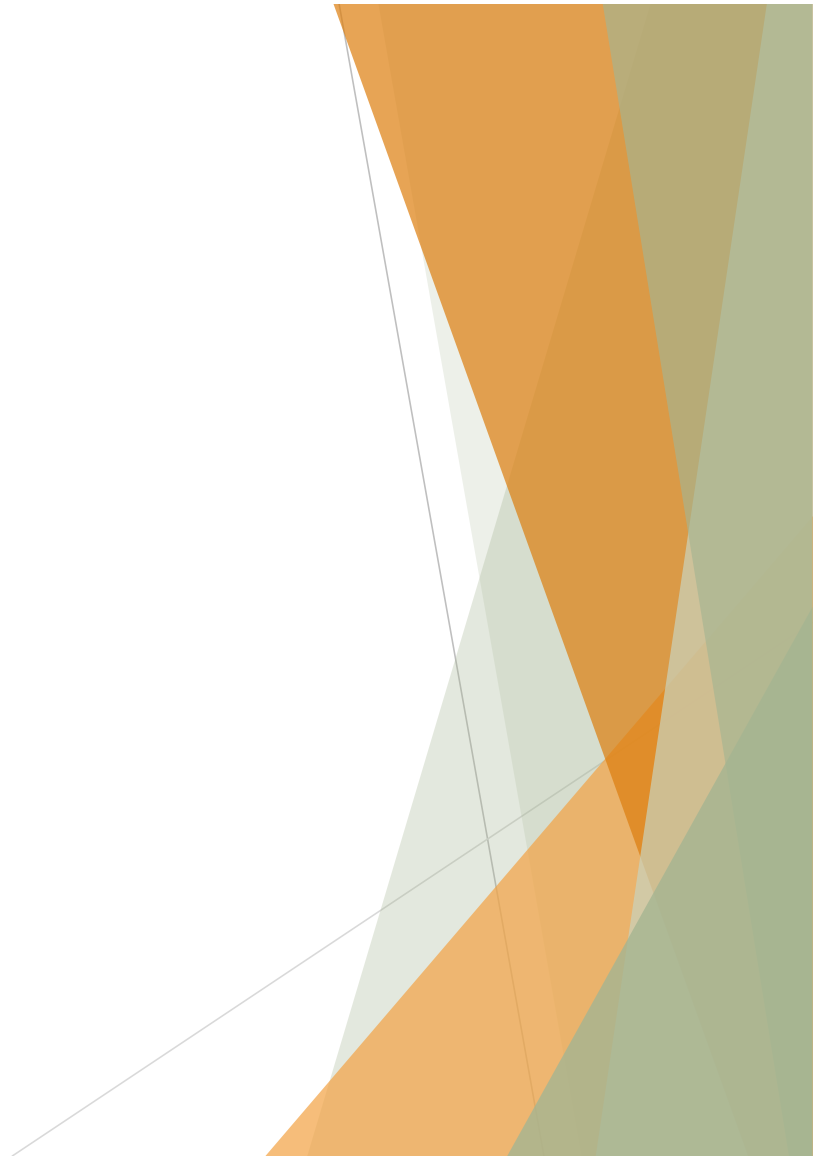

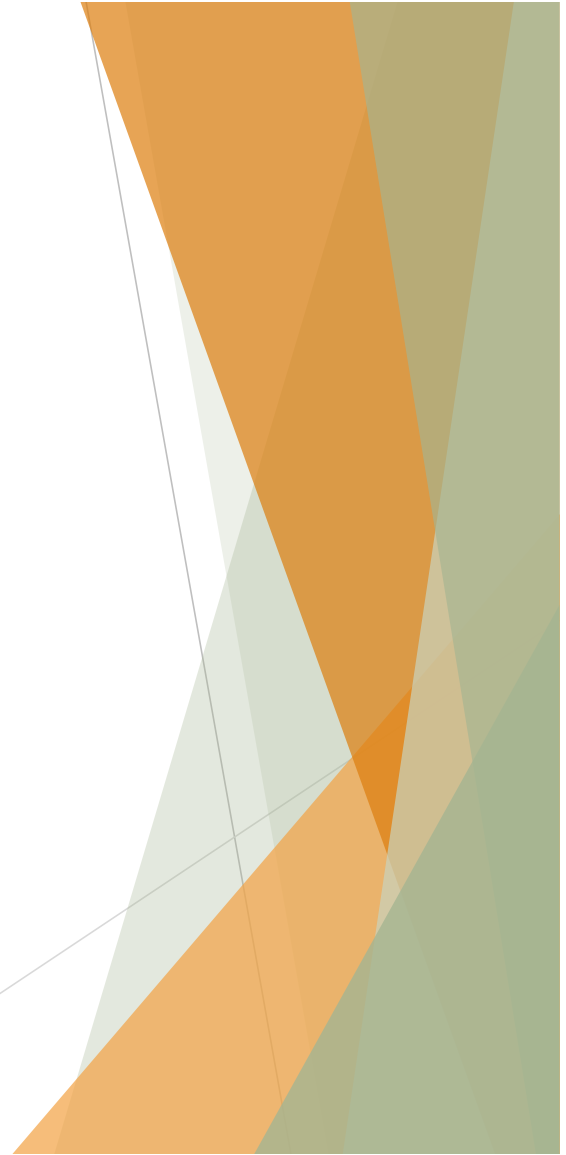
C-19 Emergency Response - NPAIHB

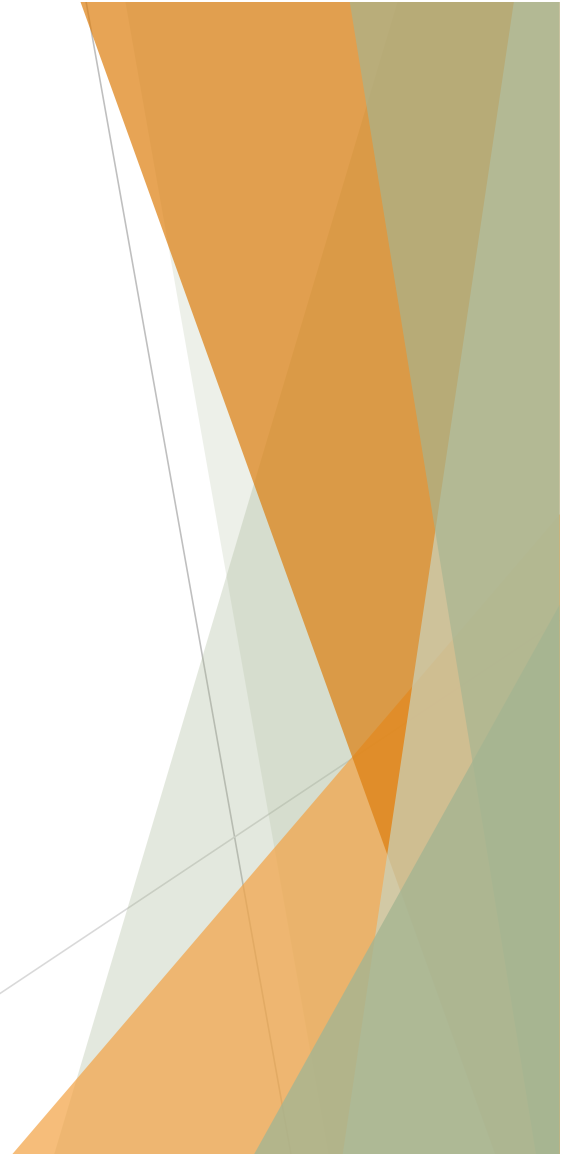

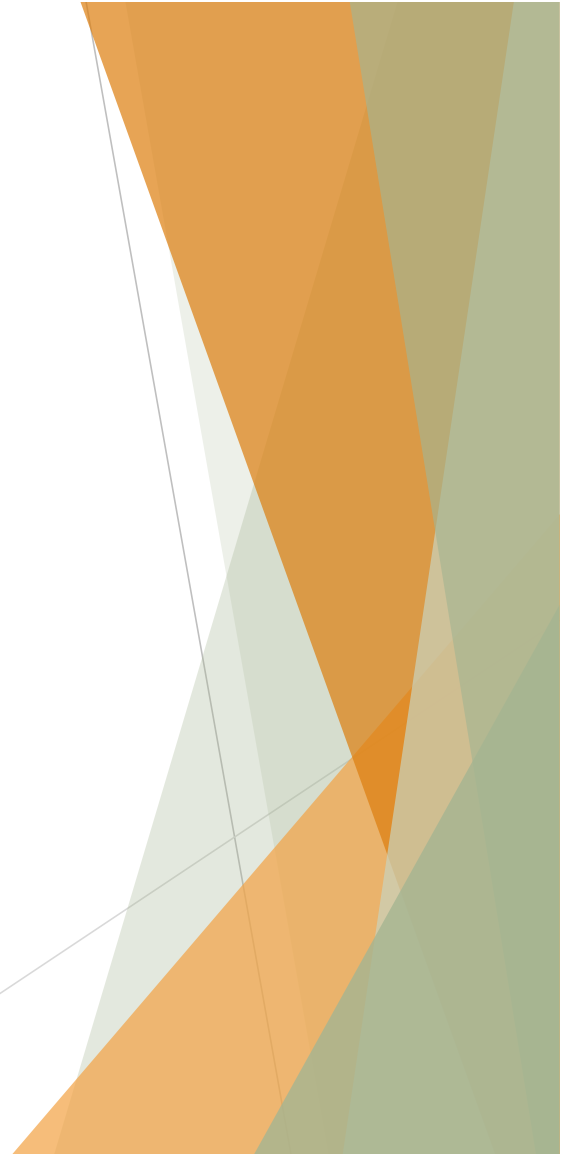
