 - ▶ Pfizer application for EUA on 12/10, Moderna expected on 12/17
 - ► CDC advisory committee meeting today to determine distribution and priority vaccination group recommendations
 - Distribution to states and IHS, must register as provider
 - Ultracold freezers

Legislative Update

- ► HR 4153 moved to the House suspension calendar. This bill authorizes the Department of Veterans Affairs (VA) and the Department of Defense (DOD) enter into agreements with Urban Indian organizations and reimburse an urban Indian organization where services are provided to beneficiaries eligible for services from either department. S 2395 recently approved by the Senate Committee on Indian Affairs and is on the Senate calendar.
- Watching a pair of bills, S 4494 and HR 8742, that would extend the deadline for the use of CARES Act funding from Dec 31, 2020 to Dec 31, 2021.
- ► Yet another COVID-19 relief package
 - ► Bi-partisan group in the senate
 - \$908b (\$160b for state, local, and tribal governments)
 - ▶ \$288b for small businesses, \$180b unemployment insurance, \$35b PRF, \$16b MCM
 - No stimulus checks, temporary liability shield
- Omnibus or Continuing Resolution, that is the question.
