I am providing you with updates concerning Indian Health Service (IHS) and Tribally operated health programs that were recently published in the Federal Register.

IHS Reimbursement Rates for Calendar Year 2007

On June 20, 2007, the Calendar Year 2007 reimbursement rates for Medicare/Medicaid services provided by IHS and Tribally operated health programs was published in the Federal Register. The rates are effective for services provided on/after January 1, 2007. The states will be issuing retroactive billing instructions shortly and we will update you of these requirements when they become available.

IHS Publishes revised CHSDA Areas

On June 21, 2007, the IHS published a revised list of Contract Health Service Delivery Areas (CHSDA) as defined under 42 CFR Part 136, Subparts A – C and Service Delivery Areas as defined by the IHS Director. The revised list replaces and supplements the previous list that was last updated in 1984, and amended in 1988. The revised list includes CHSDA designations for newly recognized Tribes.
