## **Congratulations New Portland Area Dental Therapists!**

Seven Portland Area dental therapy students graduated on June 14 from the Alaska Dental Therapy Education Program.
Each will return to their Tribe or Urban Indian Program in Idaho, Washington and Oregon to provide care to community members. Inga Weddle, Tulalip, also received her white coat and will head to Bethel for her clinical year.

Each of the graduates has spent the past two years mastering the most routine and preventive dental procedures that make up the dental therapists' scope, while each of their Tribes secured the ability to license them in a way that works for their clinics and their governments.

Coeur d'Alene spearheaded efforts in the Idaho legislature to pass a law this year that offers a state license to tribal dental therapists. Lummi Nation recently set up their own Licensing Board for their dental therapist. Swinomish led efforts in 2017 to authorize tribal dental therapists through state law, and will license the new Swinomish and Colville

graduates. The Native American Rehabilitation Association in Portland is participating in the Oregon Dental Pilot Project Program allowing dental therapists to practice under ongoing state oversight.

The Northwest Portland Area Indian Health Board celebrates each of these amazing individuals for their accomplishments, and stands with each of the Tribes and Urban Indian Program as they provide extraordinary leadership in tackling oral health disparities with this evidence-based model of care.

#### 2019 Legislative Wrap-Up

Idaho: After two years of research, discussion and collaboration, Governor Brad Little signed into law <u>S 1129</u>, the dental therapy bill sponsored by the Coeur d'Alene Tribe on March 25<sup>th</sup>. With strong support from the Nez Perce and other Idaho Tribes, the Senate passed the bill 30-4 and the House passed it 59-9. The new law authorizes the Idaho Board of Dentistry to license dental therapists who have met certain criteria to practice in tribal communities, as well as promulgate rules defining their scope of practice and level of supervision.

Washington: The Washington State
Legislature approved funding in their
2019-2021 biennium state budget of
\$6.5M to reimburse tribal health
programs for services provided to
Medicaid eligible individuals by dental
therapists (DHATs). Services provided to
Medicaid eligible individuals by DHATs
are eligible for reimbursement beginning
July 1, 2019 at the same encounter rate
given for services provided by dentists
or other providers. Additional funds
were allocated in the Capitol Budget to
support the Dental Therapy Education
Program at Skagit Valley College.

Outside the Portland Area, four new states authorized dental therapy this year! Michigan, New Mexico, Nevada and Connecticut joined the growing list of states improving access and outcomes through these high quality primary oral health providers.

## Swinomish Holds Grand Opening For New Dental Clinic and Dental Therapy Training Facility

On April 9, the Swinomish Indian Tribal Community welcomed visitors to the Grand Opening Ceremony of their newly expanded and remodeled dental clinic. The dental clinic will also house the clinical portion of the future Washington Dental Therapy Education Program.

Swinomish Chairman Brian
Cladoosby spoke to a jampacked reception area about the
historical trauma associated with
dental care for his community.
He explained the great
significance this new dental
clinic holds for the Swinomish
people and the sense of hope it
brings for the community's
health in years to come.

The new dental clinic boasts spectacular views, 16 state-of-the-art operatories, lab and sterilization rooms, and all digital records. Four of the operatories are reserved for the future Dental Therapy Education Program, as is a classroom, office space, and a locker/shower room.

The Dental Therapy Education
Program is a partnership
between Skagit Valley College
and Swinomish, and will be the
first CODA accredited Dental
Therapy Education Program in
the lower 48. The program is
working toward welcoming its
first class in autumn 2020.

## Indian Health Service releases draft CHAP Policy

Deadline for comments extended to July 8, 2019

On May 8, IHS initiated tribal consultation on a draft interim policy to expand the Community Health Aide Program (CHAP) beyond Alaska. The CHAP Tribal Advisory Group (TAG) developed the draft policy with IHS and there is still language that tribes are divided on with IHS.

There is also concern and confusion about separate but related policy actions by IHS on the CHAP and Community Health Representative (CHR) Programs. CHAP and CHR are complimentary programs and will together strengthen the health infrastructure serving Tribes throughout the country. Approval of the interim CHAP policy will not result in a funding cut or phasing out of the existing CHR program.

CHAP nationalization holds great promise for the future health care delivery system in Indian Country. It is extremely important that Tribes submit comments as this policy will allow the Portland Area to begin CHAP implementation with those Tribes that elect to utilize these providers.
