What is the definition of a BHA?

 A Behavioral Health Aide (BHA) is a counselor, health educator, and advocate. BHAs help address individual and community-based behavioral health needs, including those related to alcohol, drug and tobacco abuse as well as mental health problems such as grief, depression, suicide, and related issues. BHAs seek to achieve balance in the community by integrating their sensitivity to cultural needs with specialized training in behavioral health concerns and approaches to treatment.

Who can be Behavioral Health Aides?

- Natural helpers
- Cultural advisors and teachers
- Counselors individuals whom are good listeners
- Advocates
- Peer recovery mentors, peer support specialists, traditional health workers, community health workers or community health representatives that want to take the next step in their careers
- Anyone wanting to further explore a career in behavioral health BHA program can be a stepping stone



Who do BHAs serve?

• ENTIRE COMMUNITIES

- Elders
- Older Adults
- Adolescents
- Children
- BHAs serve Tribal Health Organizations
- BHAs may have cultural knowledge and expertise and be asked by their Tribal organizations to provide trainings to staff or local and state partners





What services do BHAs provide?

BHA I

- Wellness Promotion (crafts, culture, drumming, dancing, sports, education, etc.)
- Talking Circle on BH topic
- Education on BH topic
- Advocacy on BH topic
- Community Needs Assessment
- Screening
- Intake
- Referral
- Crisis Management
- Case Management
- Life Skill & Resource Development/Coaching
- Medication Education
- Psychoeducation
- Individual Interventions
- Group Interventions



BHA II

- Substance Use Disorder Assessment
- Substance Use Disorder Diagnosis
- Substance Use Disorder Treatment Planning
- Substance Use Disorder Treatment Implementation
- Community Readiness Assessment
- Family Interventions/Counseling

There are 2 additional advanced BHA levels:

- BHA III
- BHA/P

These levels won't be available through NW education programs immediately.

What topics do BHAs need to understand?

What other knowledge do BHAs need to have?

- Working with others communicating effectively and building relationships, may include meetings internally or with partners
- Integration with other providers within the Tribal health system
- Documentation and Medicaid billing
- Mandatory reporting
- Understanding of risk management and malpractice
- HIPAA and confidentiality
- Electronic health records
- Traditional practices



Let's break it down, the more you know!

 BHAs must be employed by an Indian Health Service facility, a Tribe, or a Tribal Health organization that operates a community health aide program. Job Titles of a BHA may vary among the tribes as they also vary in Alaska

• Certification is extremely valuable

- Process of certification will be outlined while in the BHA program, certification will be done by the Portland Area CHAP Certification Board with the guidance of the Behavioral Health Academic Review Committee (BHARC)
- Certified BHAs may become billable within their respective states and therefore become a sustainable resource for their organization
- BHAs must practice under a master's level clinical supervisor
- An Electronic Behavioral Health Aide Manual (eBHAM) will be available for BHAs to reference during and after completion of the program




Educational Pathways

- BHA-1 or BHA-2 whichever level is a better fit depending on:
- Alternative (academic) vs. Specialized (non-academic) Matrix
 - Student can work with Coordinator to determine which level they would be the best fit for
- Full time student vs. Part time student
 - Level 1 = 12 months
 - Level 2 = 18 months
- 3 pathways will be available for students:
 - Certificate/AA in Social Work at Heritage University*
 - AA in Chemical Dependency from Northwest Indian College
 - Certificate/AA in Behavioral Health from either Institution




BHA Education Program Timeline



Goals of the Portland Area CHAP Certification Board (PACCB)

- 1) Certification application review and recommendation of Tribal BHA/Ps, DHA/Ts, and CHA/Ps;
- 2) Certification of all Tribal education and training programs created for BHA/Ps, DHA/Ts, and CHAPs;
- 3) Approve all continuing education (CE) of Tribal Community Health Providers (TCHP);
- 4) Address health disparities within the Tribal Health System (THS) by review and recommendation of individual, education programs and continuing education by maintaining certification standards. The PACCB will create opportunities to increase mid-level CHAP providers within the THS to increase access to quality care.

| Position | Nominating Tribal Organization or Partner | Role on the PACCB |
| 1 – PAIHS Director | IHS Area Director | This member is appointed by the Portland Area IHS Director as required by IHS Circular No. 20-06. This delegate serves as a liaison between PAIHS and PACCB. |
| 2- NPAIHB Delegate | NPAIHB Delegates | This member is nominated by the NPAIHB delegates to also serve as a liaison between the NPAIHB Delegates and the PACCB. |
| 3 – NPAIHB E.D. | NPAIHB Executive Director | This member is nominated by the NPAIHB Executive Director and serves as a liaison between NPAIHB and the PACCB. |
| 4 – BHA/P Association | BHA/P Association | This member is nominated by the BHA/P Association of BHA/Ps working within a TCHP program for the Portland Area Tribes. This position serves as a liaison between the BHA/P Association and the PACCB. |
| 5 – CHA/P Association | CHA/P Association | This member is nominated by the CHA/P Association of CHA/Ps working within a TCHP program for the Portland Area Tribes. This position serves as a liaison between the CHA/P Association and the PACCB. (This nomination is delayed until the CHA/P Association is operational). |
| 6 – DHA/T Association | DHA/T Association | This member is nominated by the DHA/T Association of DHA/Ts working within a TCHP program for the Portland Area Tribes. This position serves as a liaison between the DHA/T Association and the PACCB. |
| 7 - BHARC | BHARC Association | This member is nominated by the BHARC who is a LCSW or Licensed MSW working within CHAP for the Portland Area Tribes or IHS. |
| 8 - CHARC | CHARC Association | This member is nominated by the CHARC who is a Licensed Physician (preferred) or could be a licensed Nurse Practitioner or Physician Assistant working within CHAP for the Portland Area Tribes or IHS. (nomination delayed until CHARC is operational). |
| 9 - DHARC | DHARC Association | This member is nominated by the DHARC who is a DMD or DDS working within CHAP for the Portland Area Tribes or IHS. |
| 10 – ID DOH | Idaho Department of Health and Welfare, Division of Medicaid | This member nominated by Idaho Department of Health and Welfare, Division of Medicaid (DOH) and serves as a liaison between the DOH and PACCB. |
| 11 – OR OHA | Oregon Health Authority | This member is nominated by the Oregon Health Authority (OHA) and serves as a liaison between the OHA and PACCB. |
| 12 – WA HCA | Washington Healthcare Authority | This member is nominated by the Washington State Healthcare Authority (HCA) and serves as a liaison between the HCA and PACCB. |
| 13 – CHAP Education Program | PA CHAP Education Programs | This member is nominated by the Portland Area CHAP education programs. |

PACCB Update

- April 2021 Quarterly Board Meeting, delegates approved the resolution establishing the recommended 13-member seating chart and roles for the PACCB.
- On April 14, 2021, Area Director Seyler initiated tribal consultation by releasing the CHAP Dear Tribal Leader Letter to all Portland Area Tribes seeking input on the establishment of the PACCB, recommendations accepted by IHS area office
- NPAIHB CHAP Advisory Workgroup recruited 13 individuals that are qualified to sit on the PACCB, forwarded nominations to Portland Area IHS for final approval
- First PACCB meeting will be held August 3 and 5


