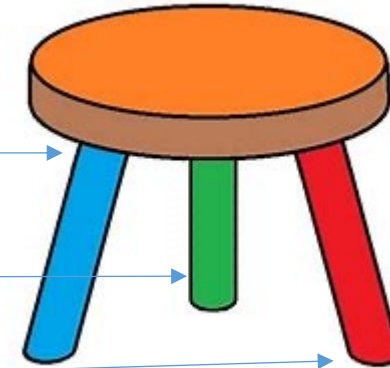
# CIEP History

- A statewide disability advisory group that provides technical advice on inclusive emergency planning.
- Creating partnerships that work for a more effective quality planning, response, and recovery.
- Funded through a federal grant from DOH; Grant first began in July 2015. Now in 8<sup>th</sup> year.

# Inclusive Planning

## 3 Pillars of Accessibility:

- Effective Communication Access
- Programmatic Access
- Physical Access



Like a 3-legged stool, each pillar supports the other pillars

# Defining Access and Functional Needs

---

## **What are access & functional needs?**

---

Resources, services or supports that allow a person to maintain their independence and thrive in their environment. So essentially moving away from that medical model and just thinking about access of functional needs in terms of ensuring that everybody has the same access as anyone else.

---

## **What are access barriers?**

---

Access barriers are any environmental, programmatic or physical obstacles that prevent people with access and functional needs from participating in or receiving services or resources available to everyone.

## Who has Access and Functional Needs?

**Examples of individuals with access and functional needs include, but not limited to individuals who:**

- use sign language or assistive communication devices
- use wheelchairs or other mobility aids
- are blind or have low vision
- use service animals
- have cognitive disabilities




## Who else has Access and Functional Needs?

- **More examples of individuals with access and functional needs include, but not limited to individuals who:**
- have limited English proficiency
- are women in late-stage pregnancy
- rely on public transportation
- are unsheltered individuals





# People with Disabilities are Subject Matter Experts

- Knowledge of resources and supports (service vs advocacy)
  - Include people with various disabilities as contributors and collaborators
  - Qualified advisors who can think through issues from disability, access and functional needs, and universal design perspectives.
  - CIEP can help make connections
- 



## Why Inclusion of People with Disabilities?

Planning for and not with people with disabilities reflects an old paradigm “a lot about us without us.”

Today it is

**“Nothing about us without us!”**

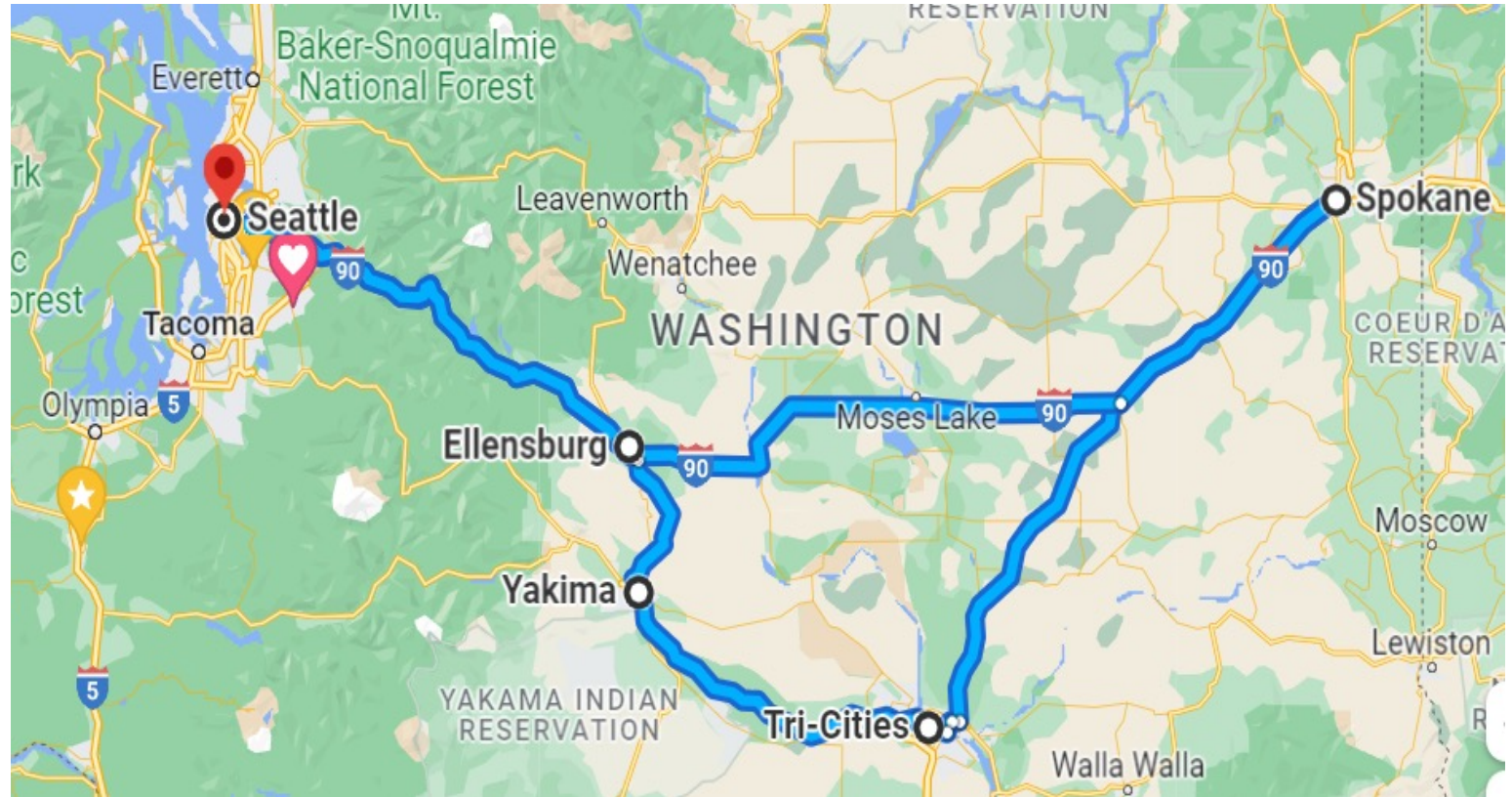
