 □ Oral Storytelling/Poetry (including visual arts, dance, and drawing)

All participants will have the opportunity to exchange ideas with California, Idaho, Oregon, and Washington Tribal Leaders as well as attend a Cultural Sharing Event Dinner with Board of Directors.

While the conference is free (including meals and snacks during the workshop and dinner on Wednesday night), travel to and from Canyonville, OR and lodging are the responsibilities of the youth, families, &/or Tribe. Each group of youth that attends must be accompanied by at least one chaperone from their community.
