Meeting Purpose: Review Portland Area Behavioral Health Academic Review Committee (PA BHARC) updates and discuss key issues related to Behavioral Health Aide (BHA) program development.

Key Takeaways

- Heritage University BHA program going on 1-year pause; need to develop plan for current students and future inquiries
- 11 BHA students graduated from Northwest Indian College; presentations highlighted cultural integration
- Continuing education workgroup needed to develop CE requirements for certified BHAs
- Challenges with clinical supervisor transitions impacting BHA certification process

Today's Topics

National CHAP Board Update

- Next meeting July 7-8 in Phoenix; closed meetings for now as board establishes itself
- Standards of Procedures draft sent out for review; tight timeline for initial feedback
- Behavioral Health, Dental, and Community Health Aide workgroups being formed

Heritage University BHA Program Pause

- 1-year pause starting August 1st due to Dr. Wynn's sabbatical and budget concerns
- Current students will be supported to graduate in early 2026
- Need to develop plan for tracking inquiries and re-engaging when program restarts

BHARC to recommend Heritage provide detailed update to PACCB

Northwest Indian College BHA Graduations

- 11 BHA graduates this year from diverse tribal backgrounds
- Presentations integrated traditional practices, clinical therapies, and personal growth
- Students developed culturally-grounded interventions (e.g. dance therapy) for practicum
- Graduation ceremony emphasized prayer, family involvement, and cultural elements

Continuing Education Workgroup

- Need to establish CE requirements for certified BHAs
- Consider accepting state-approved CE and tribal-based practices
- Identify key training needs: early childhood mental health, substance-specific, grief
- Plan to gather input from current BHAs on desired CE topics

Clinical Supervisor Challenges

- Issues when supervisors leave mid-certification process
- Need FAQ/toolkit to orient new supervisors to BHA program requirements
- Consider requiring transition plan/narrative when supervisors depart

Next Steps

- Create supervisor toolkit/FAQ to orient clinical supervisors to BHA program
- Develop continuing education workgroup and draft initial CE requirements
- Plan in-person gathering of BHA students from both programs before end of August
- Reach out to Dr. Wynn for Heritage update to present at August PACCB meeting
- Schedule next BARC meeting for July 16th, 12-1:30pm

- Develop supervisor toolkit. Include FAQ for supervisors, liability/malpractice info, responsibilities.
