Meeting Summary for Wednesday, November 19, 2025

Action Taken: Quorum was not established at today's meeting. We'll review and approve November's Agenda and October Minutes at the December 17, 2025, meeting, if quorum is established.

Meeting Purpose: Review Portland Area Behavioral Health Academic Review Committee (PA-BHARC) updates and discuss key issues related to Behavioral Health Aide (BHA) program development.

Key Takeaways:

The focus of the PA-BHARC is curricula review, and not the review of BHA certification applications.

Today's Topics:

Portland Area CHAP Certification Board (PACCB) Updates:

- Portland Area CHAP Certification Board updates provided by Dolores Jimerson.
 - The next PACCB meeting is scheduled for Thursday, December 4, 2025, - Friday, December 5, 2025.
 - The PACCB application deadline was 10/31/2025.
 - No BHA certification applications currently.
 - Ms. Jimerson updated that Yakima Tribe had requested TA specific to the lack of case management training provided at Heritage University.
 - TA request - development of continuing education designed for case management.
 - Ms. Jimerson updated on the Nation CHAP Board (NCHAPB) BHA workgroup, which was held Monday, November 17, 2025.
 - The workgroup is starting with a line-by-line review of the proposed Standards and Procedures (S&Ps).
 - This workgroup is meeting monthly until finalization of the national S&Ps.
 - It was reported at the NCHAPB that the Alaska CHAP Certification Board (CHAPCB) "will not be receiving any additional funding for expansion".
- BHA student updates provided by Ms. Katie Hunsberger.

- Northwest Indian College (NWIC) open recruitment for the sixth cohort with prioritization of cohort seats for Portland Area Tribes and Tribal Organizations.
 - Application due date: 11/26/2025
 - Cohort start date: 01/05/2026
 - Cohort recruitment goal: 14 students from the Portland Area (WA, OR, and ID).
- Ms. Hunsberger discussed challenges of finding clinical supervision for BHA students, so at this time students with clinical supervision will be prioritized for the next cohort.
- Ms. Hunsberger also discussed the need for information to help students understand the importance of pursuing BHA certification, post education program completion.
- Ms. Jimerson discussed the contract with NWIC is being drafted to reflect an updated scope of work and increased budget, due to the current BHA program moratorium at Heritage University.
- Ms. Jimerson shared news that the Coquille Tribe is the first tribe in Oregon to create a BHA position and offer clinical supervision practicum.

PA-BHARC Discussion Items:

- Review of BHARC seating matrix. Chair Gorman requested the BHARC consider adding the BHA education programs to the seating matrix.
- Discussion for Vice Chair nominations.
- Initial bylaw review by Chair Gorman.
 - Chair Gorman emphasized the need to indigenize the bylaws to reflect the direction of the BHA program, the PACCB and the PA-BHARC, to be rooted in indigenous values of balance and wellness.
 - Chair Gorman discussed the importance of community-mindedness and involving all voices in the bylaw audit process.
 - A work group is scheduled for December 10, 2025, to do an in-depth review of the bylaws.
 - Suggested edits included editing the seat definitions to better reflect the current needs of the PA-BHARC, BHA Program and PACCB.
 - Suggested additions:
 - Adding a seat for National CHAP Representative.
 - Adding a seat for an elder “culture keeper”.
 - Adding a seat for a behavioral health professional with a work history including the BHA program, or the PA-BHARC.
 - Adding a seat for an out-of-area behavioral health or BHA representative.
 - The proposed bylaw edits will be added to the agenda for the next PA-BHARC.

- Work on increasing committee engagement.
